Bequests are gifts you make from your Will or personal trust. They can be gifts of cash, stock, real estate or other assets. Bequests allow you to support your community without affecting your current lifestyle; and if your situation changes, bequests are revocable during your lifetime.

Putting a charitable gift in your Will doesn't require much time. And it doesn't require a lot of money. Bequests of any amount can have an impact far greater and more lasting than you might expect.

Those who include a charitable bequest in their estate plans become immortalised to the causes, the organisations and the community they support.

Even the most modest of gifts will grow into a powerful engine for good.

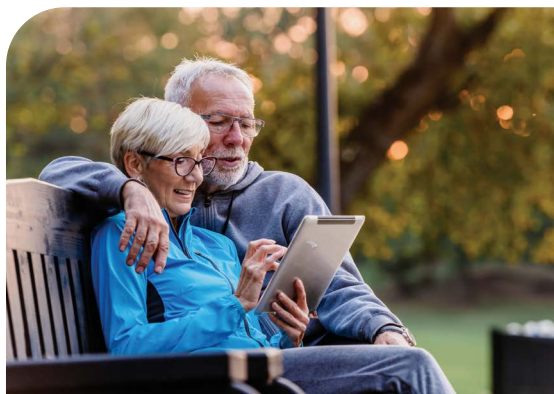

A Gift for Unspecified Local Community Impact Initiatives

I give and bequeath to Community Foundation for Albury Wodonga Region Ltd, currently trading as "Border Trust" (ABN 34 111 519 012), ("Border Trust") free of all duties, [specific dollar amount / percentage of my estate / residue of my estate / specific asset], for its general purposes to support community initiatives across the Border Region, as determined from time to time by its duly appointed Board.

I declare that the receipt of an authorised officer of Border Trust will be a sufficient discharge to my Executors, and that my Executors will not be bound to see the application of this bequest.

OR

A Gift aligned to a Local Cause, Issue or Initiative

I give and bequeath to Community Foundation for Albury Wodonga Region Ltd, currently trading as "Border Trust" (ABN 34 111 519 012), ("Border Trust") free of all duties, [specific dollar amount / percentage of my estate / residue of my estate / specific asset], to be used to support [broadly stated charitable cause, e.g., 'education programs,' 'health and wellbeing,' 'environmental sustainability'] across the Border Region, as determined from time to time by its duly appointed Board.

I declare that the receipt of an authorised officer of Border Trust will be a sufficient discharge to my Executors, and that my Executors will not be bound to see the application of this bequest.
